CAPTRUST Scholarship Official Rules

1. ELIGIBILITY

The CAPTRUST Scholarship (the "Scholarship") is open to students in the United States who are:

- 16 years of age or older at the time of entry.

2. ENTRY PERIOD & TERMS

- The Scholarship application opens on February 19, 2025 and closes on May 31, 2025 at 11:59 PM EST.
- Applications submitted after the closing date will not be considered.
- Only the first 2,500 eligible submissions, per semester, will be considered.
- Students are only permitted to win the CAPTRUST scholarship once.

3. HOW TO APPLY

- Eligible individuals must complete the following steps to apply:
- Fill out the official application form on the CAPTRUST website.
- Submit an original essay which shall include your personal goals, accomplishments, career goals, and community impact.
- Submit your college or high school transcript

*A Headshot will be requested for winners only after application process.

4. SELECTION CRITERIA

Scholarship recipients will be selected based on their GPA and the quality of their essay submission, including creativity, originality, and alignment with the scholarship theme. No applicant will be discriminated against on the basis of sex, marital status, race, color, religion, national origin, or age. All decisions made by the scholarship committee are final.

5. AWARD

Five (5) scholarship(s) in the amount of \$2,000 each will be awarded. The funds will be paid directly to the individual winner by check mailed to the recipient's address.

6. CONDITIONS

By entering, participants agree to:

- Accept and be bound by these Official Rules.
- Allow CAPTRUST to use their name, likeness, and submission for promotional purposes without additional compensation, unless prohibited by law.
- Certify that their submission is original, does not involve the use of artificial intelligence (AI) and does not infringe on the rights of any third party.
- Understand any taxes on award, if any, are the winner's responsibility.

7. DISQUALIFICATION

CAPTRUST reserves the right to disqualify any participant who violates these rules, submits false information, or engages in or inappropriate behavior or fraudulent activity.
